SUMMER SCHOOL 2026: GENERAL POLICY STATEMENT

TUITION & FEES *All tuition and payments are non-transferable and non-refundable.*

- The summer school registration fee is **\$155 before May 1st and \$180 after.**
- All parents and students must enter and exit through the office during office hours or the main gate after office hours.
- Tuition payments are due Monday morning of the week they are attending. *Payments made after will have a \$10 late fee added.* Tuition will not be prorated for any excused or unexcused absences. The school reserves the right to cancel enrollment for any child for unpaid tuition, effective the first day of the following week.
- We do accept CCRC tuition assistance, however parents must apply through CCRC’s website and if approved pick us as the provider.
- Friday Field Trip fees are not included with tuition price and will vary by week. If not attending the trip, students must go home.

DRESS CODE

All students must adhere to the dress code while on school grounds and at school related functions. Any violation will be addressed immediately at the discretion of the staff.

- NO baggy or oversized clothing including pants, shorts, belts, shirts, etc. Belts may not hang down from the waist. Pants must be the size of the natural waist.
- NO excessive jewelry such as dangling or large hooped earrings, and/or chains.
- NO articles of clothing with inappropriate writings, advertisements, pictures or insignias.
- NO tube tops or crop tops, stomach must be covered and shirts must have straps/sleeves.
- NO open-toe shoes or high heels.
- On water activity days or field trips, girls may not wear bikinis. No zippers, hard plastic buttons or dangling strings. You must bring your own towel and sunscreen.

CONDUCT/BEHAVIOR

We expect every student, parent, and guardian to demonstrate good citizenship and Christian values while they are on campus. Gossip, bad language, argumentative tone of voice or behavior, and/or any act of aggression, rough-housing, and bullying will not be accepted. The school reserves the right to cancel enrollment at any time if proper behavior is not maintained and **any payments collected will be non-transferrable and non-refundable.**

- Be respectful at all times to staff and peers.
- Adhere to the teacher's classroom and the school's policies. (Refer to the Parent-Student Handbook available at www.GlenoaksSchools.com)
- Usage of inappropriate language, hitting, pushing, or bullying is prohibited.
- Parents of the student will assume all financial responsibilities for vandalism, theft, and destruction of property caused by the student.

Glenoaks Christian Schools makes every effort to redirect the students to learn from their mistakes and make better choices in the future. Students at fault will be given appropriate consequences as an opportunity for them to reflect. **Serious offenses may result in immediate suspension or expulsion without prior warning. All disciplinary actions will be finalized at the discretion of the principal.**

CHILD PICK UP

Adults 18 years and older must be on the emergency card to pick up students. The school cannot release any child to an unauthorized person without verbal authorization from the guardian. Students are not permitted to leave campus or walk home alone. If the child is not picked up from school on time, they will be taken to daycare. Daily daycare will be available at the rate of **\$10** per hour or portion thereof. It is available from **7:00 a.m. – 9:00 a.m.** and **3:00 p.m. - 6:00 p.m.** Any child picked up after **6:00 p.m.** will be charged **\$2** per minute and is due at the time of pickup.

ILLNESS

Parents assume the responsibility of notifying the school of any communicable diseases (i.e cold, flu, lice, pink eye, covid, etc.) and will keep their child at home until fully recovered. Parents will be contacted to pick up their child when the student has a fever of 100.0 degrees or higher, has active or inactive lice or nits, or vomits. Children are required to stay home until they have gone 24 hours without fever or vomiting.

ELECTRONIC DEVICES

Students are **not allowed** to bring personal electronic devices (i.e. phones, tablets, gaming systems, etc.) to school. However, teachers may use an "Electronic Game Day" incentive for their class at their own discretion. During that time, items must be left in backpacks and turned off until given permission from the teacher. If any are used, seen, or heard during the school day, they will be confiscated and kept in the

possession of the administration. It is the responsibility of the parent/guardian to reclaim them from the office. The school has a zero tolerance policy for any inappropriate use of electronic items. We are also not responsible for any lost, stolen or damaged items.

MEDIA CONSENT

By registering your child you are consenting to: PG movies being shown in and out of the classrooms, internet use on personal and school owned devices, and photography/videography for various reasons including but not limited to school projects, social media posts, and bulletin boards inside and outside the classroom.

SNACKS & LUNCHES

Snacks may be brought from home or purchased from our “Student Store” during recess/lunch and 15 minutes before & after school. All items in our “Student Store” are one dollar. Payments can be made by the student in the store with cash or adults can purchase a “Snack Card” from the front office with cash, check or card. “Snack Cards” are available in increments of \$5 each, and will be marked off as it is used.

Parents can purchase hot lunch at the beginning of the week for \$10 per day, bring something from home or have one dropped off or delivered before noon. We are not able to refrigerate or heat up any items. If your child does not have lunch, an emergency lunch will automatically be given to them (uncrustable, cup-of-noodles or easy mac with a juice and chips) at the cost of \$10, which is due at time of pick up.

SUGGESTED SUPPLIES NEEDED

Students will be responsible to bring their own supplies to school. The school will be not responsible for any lost or stolen supplies, so be sure to label each of them. Parents will assume financial responsibility if any assigned textbooks or equipment is damaged, lost, or stolen. *Supplies may vary by class and do not need to be new or unused.*
